Important Safeguards

1. Read Instructions

All the safety and operating instructions should be read before the appliance is operated.

2. Retain Instructions

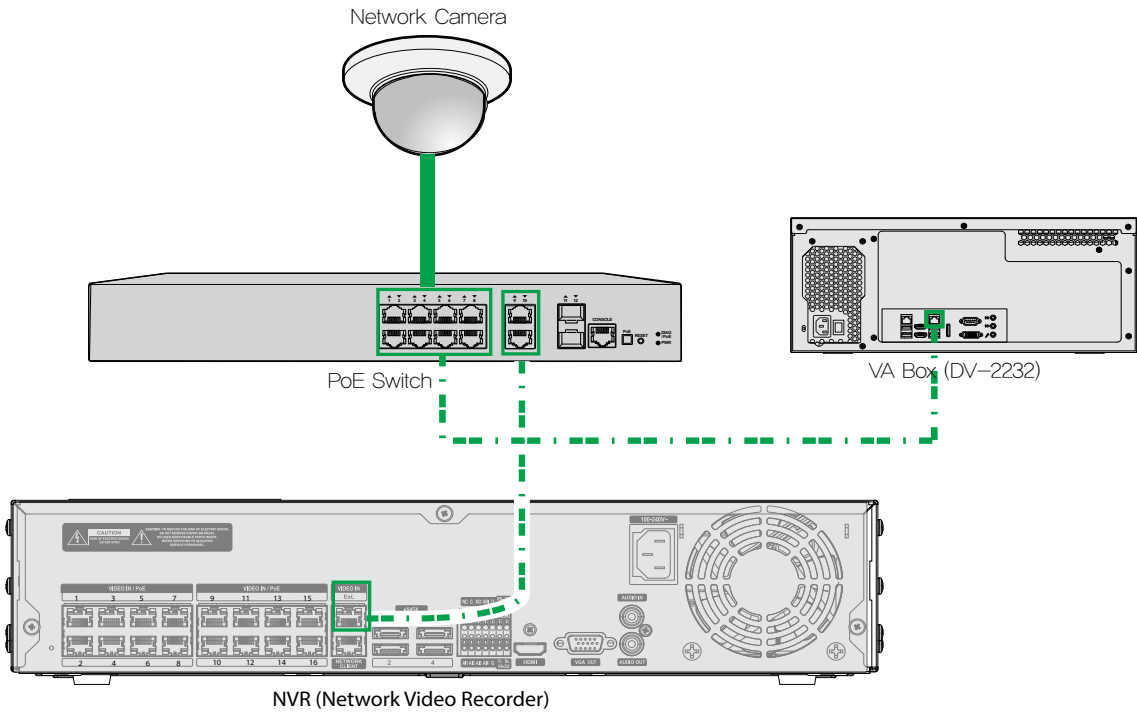

Product Features

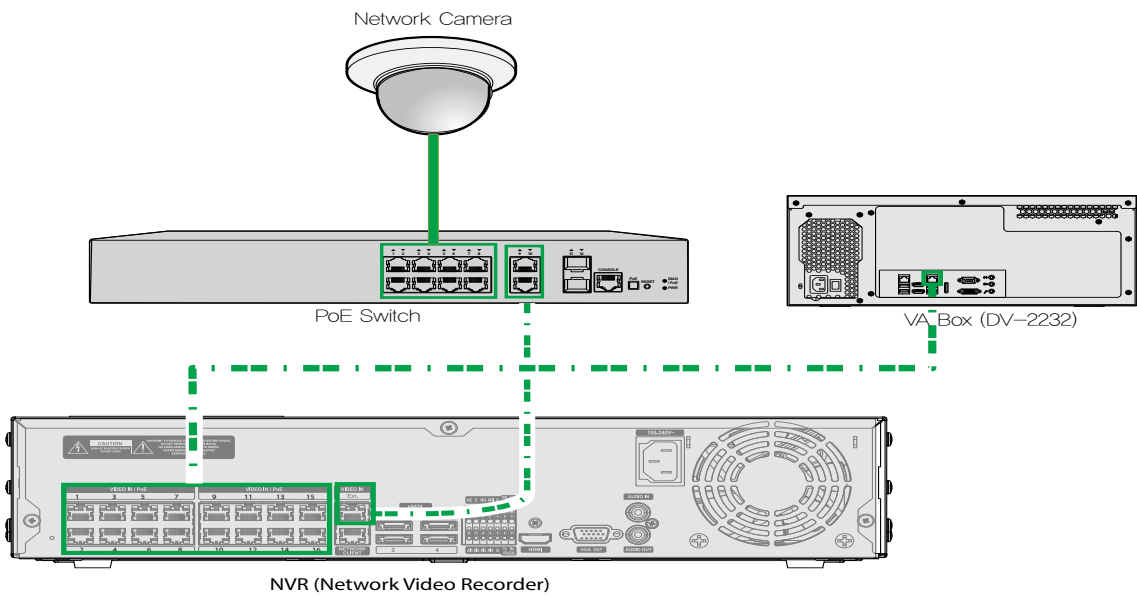
This VA in the Box (VA Box) analyzes the live video from DirectIP™ cameras and transmits the video over Ethernet connections. This product offers the following features:

- 32-channel H.264 and H.265 IP camera supported
- DirectIP™ protocol supported
- Various image analysis function such as People Counting, Crowd Detection, Social Distancing Violation, Mask Rule Violation.
 - **People Counting** : Counts the number of people passing through the line on the video.
 - **Crowd Detection** : Alarm occurs according to the analysis of the number of people detected in the video.
 - **Social Distancing Violation** : Alarm occurs according to the estimating and analyzing the distance between people detected in the video.
 - **Mask Rule Violation** : Selected camera detects a face and an event occurs according to the mask wearing rule set on the face.
- Configuration of device settings and integrated management of multiple VA Boxes on the NVR (Network Video Recorder)

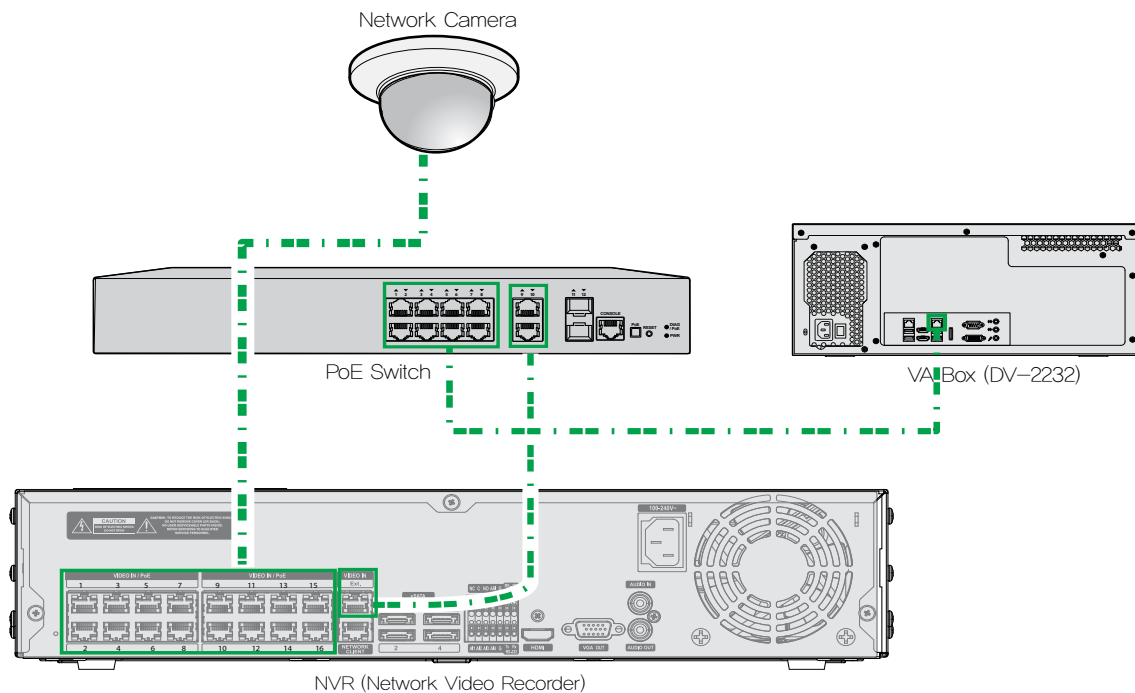
Example 1 : VA Box Connection Diagram Using PoE Switch



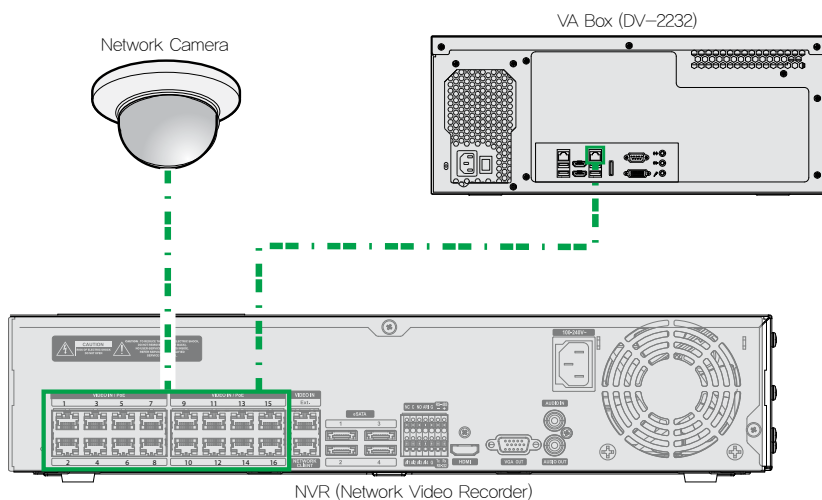
Example 2 : VA Box Connection Diagram Using PoE Switch

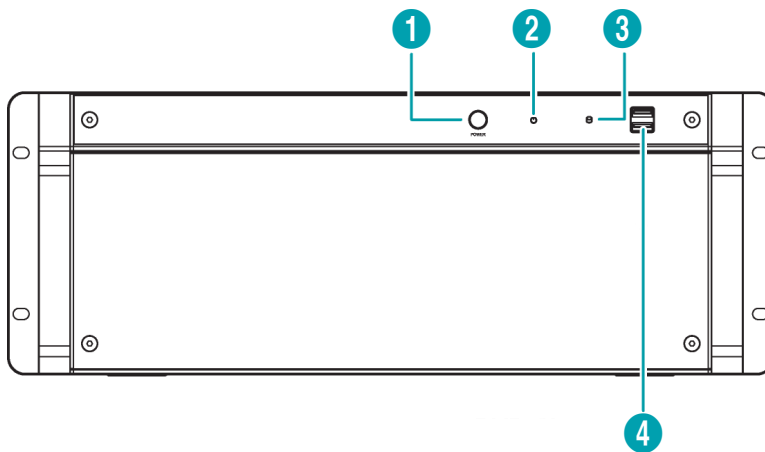

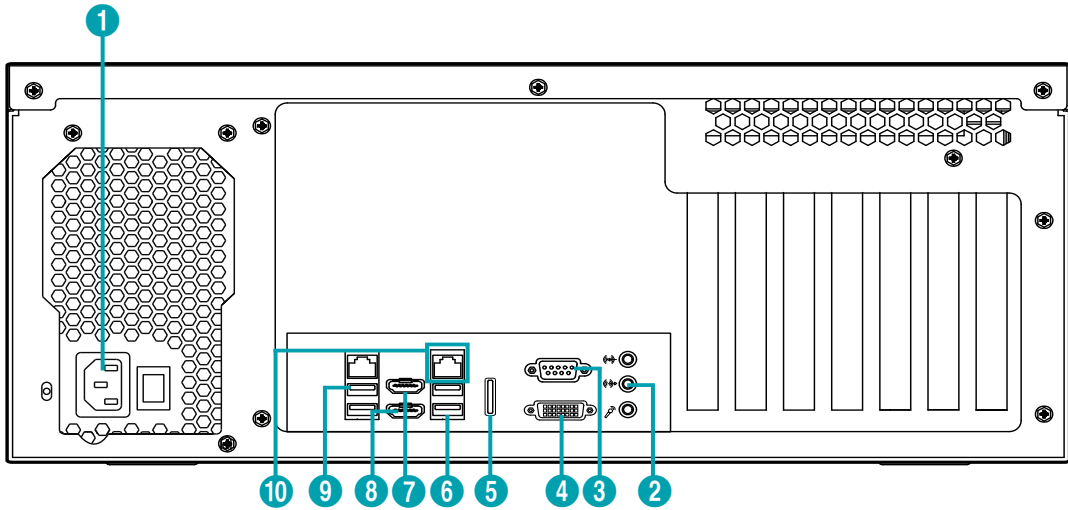

① Power In

Connect a power cord.

② Audio Out

Connect an amplifier (Line-out). The NVR does not have amplified audio output, so you will need a speaker with an amplifier.

③ RS232

Connect a remote control device for RS232 communication.

④ VGA (D-Sub)

Connect an HD (High-Definition) PC monitor which supports a D-Sub interface. Connect a monitor before turning on the system. Video might not be displayed on the monitor when connecting a monitor after turning on the system.

⑤ E-SATA

Connect an external hard disk drive which supports an eSATA interface.

⑥ USB 3.0

Connect USB devices such as a mouse, keyboard, USB storage device or printer.

⑦ DP

Connect an HD (High-Definition) PC monitor which supports a DP interface.

⑧ HDMI

Connect an HD (High-Definition) PC monitor which supports an HDMI interface.

⑩ Network (LAN1)

Connect a CAT 5e or higher cable with an RJ-45 connector.

Camera Installation

General Guideline for VA Box Camera

In order to properly operate and manage VA Box such as cameras, especially people counting, Crowd Detection, Social distance violations, and mask rule violations, the following must be applied.

Make sure that the lighting is sufficient.



[Make sure there is enough light]

The Exceeding the limit, Crowd Detection, Social Distancing Violation and Mask Rule Violation of the VA in the Box may cause errors in actual measurements. So there may be errors in the actual measurement. In the following conditions, the analytical performance may suffer due to faulty detections.

- If there is not enough light.
- If it is difficult to obtain a sufficient view.
- If only part of the object is visible at the edge of the field of view.
- When several extremely fast moving objects appear randomly in the image.
- When a person is lying down or sitting without standing upright.
- When a moving object is too close to the camera.
- When several people move as a group and their motions block one another.
- When an object moves quickly.
- If an object is reflected on the floor, wall, glass, metal or water or makes a shadow from a light source.
- If the position of the camera differs from the direction of a light source and it makes a shadow.
- Fisheye analysis not supported.
- Corridor Format analysis not recommended.
- When it can be recognized as a person such as a mannequin or video screen.

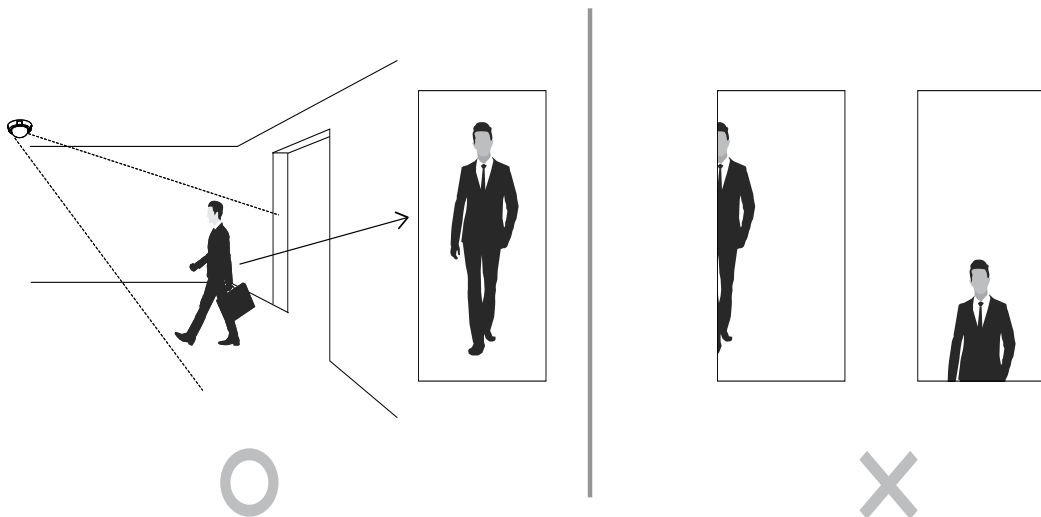
People Counting

Camera Installation

The whole body appears at the place to be counted, and it is installed diagonally so that the front and rear people passing by do not block each other.

- It is installed so that the movement of a person passing through the boundary line can be easily captured.

- The image should be installed so that the person does not tilt more than 30 degrees, and the size of the person on the image should be larger than 1/16th of the image size.



In the case of VA in the Box people counting, the recognition rate may decrease in the following cases.

- If there is a narrow gap between people passing through the counter line.
- A congested environment in which both incoming and outgoing are made at the same time based on the counting line.

Crowd Detection

In the case of VA in the Box Crowd Detection, the recognition rate may decrease in the following cases.

- Place with a large floating population
- People who near the camera cover the body of the person behind.

Social Distancing Violation



In the case of VA in the Box Social Distancing Violation, the recognition rate may decrease in the following cases.

- Only part of the human body is visible
- The perspective of distant and close people is lost due to a horizontal or low-angle camera.
- People close to the camera occupy too much area of the image to obscure nearby people
- People who near the camera cover the person in around.

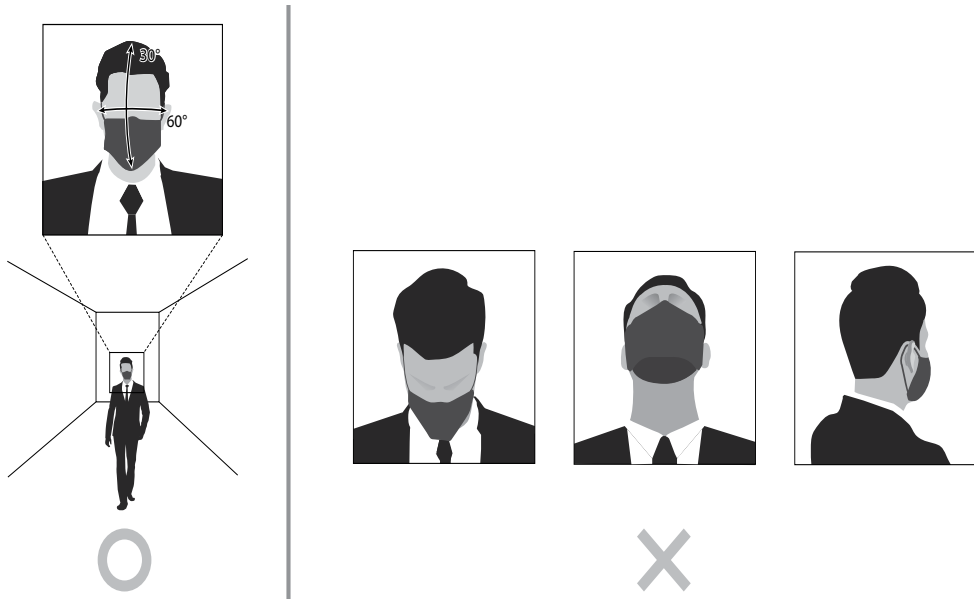
Mask Rule Violation

Camera Installation

The conditions must be satisfied to determine whether the subject violates the mask rules. It is recommended that the camera be installed at the average height of a person.

- When the resolution is 1920x1080, it can be detected when the size of the face is over 50x50 pixels.



- Based on the front of a person's face, it is detected only within 30°C up and down and 60°C left and right.




Part 3 - VA in the Box Setting via NVR

<Before You Configure VA settings>

Configure basic VA Box settings and all other system settings.


-  Screen images may vary depending on the model.
-  When using the camera with Intellegent Codec, it could delay the image analysis up to 10 seconds.

-  When the MAT (Motion Adaptive Transmission) function is active, the image analysis may not work properly.
- It is recommended that you do not use the MAT function of the associated camera to increase the accuracy of the image analysis.
- In the case of cameras to be used for video analysis, if one or more stream settings are not set to 640x360@10ips or more and 2mp@10ips or less, the video analysis may not work properly.

Camera Protocol

VA Box supports **DirectIP™** protocol.

- **DirectIP™** protocol:
 - Using with a DirectIP™ NVR enables VA Box use without the need to configure network settings.
 - The DirectIP™ NVR also allows you to control all VA Box settings directly from the NVR, without the need for a computer.

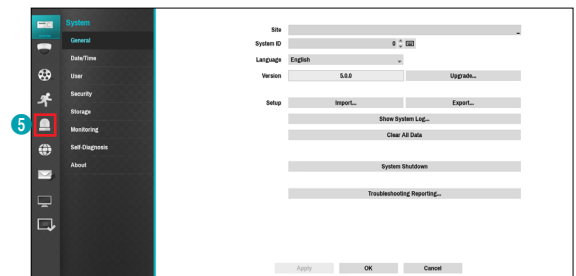
Firmware Upgrade


Remote software upgrade is not supported. If necessary, Prepare a monitor, keyboard, and firmware for the device to perform the upgrade yourself.

VA Box Setup

Select **5 Device Setup-VA Box** from the setup menu. Login with an ID that has permission to access the setup menu is needed to access and make changes to the Setup menu.

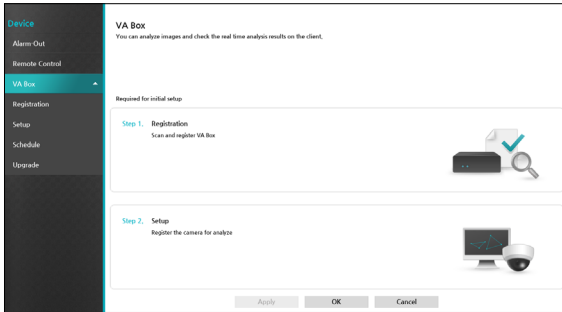
- 1 While in Live mode, press the remote control's **SETUP** button or select Live menu > Setup using the mouse.



- 2 Use the remote control's arrow buttons to select an option and then press the remote control's  button or left-click on the option using the mouse.

VA Box

By analyzing camera images, you can check real-time analysis results from a client program such as the IDIS Center.



- VA Box can only analyze the video from the camera using H.264 and H.265.

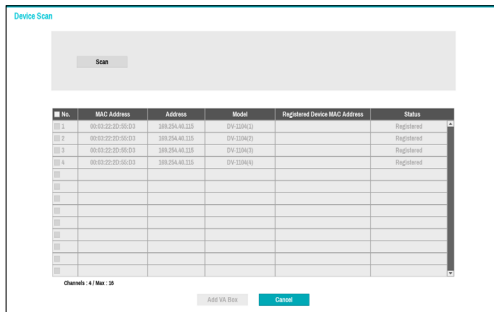

- **Title:** Edit the VA Box's name.
- **MAC Address:** Displays the VA Box's MAC address registered to the NVR.
- **Address:** Displays the VA Box's IP address registered to the NVR.
- **Model:** Indicates the VA Box's model.
- **Scan:** Select to scan and register the device connected to the NVR.

Device Scan

Scan the device under **Registration - Scan**.



- **No.:** Select the registered VA Box number and click the **Add Box** button to register the camera.
- **MAC Address:** Displays the scanned device's MAC address.
- **Address:** Displays the scanned device's IP address.
- **Model:** Indicates the device model.
- **Registered Device MAC Address:** Displays the MAC address of the NVR to have registered VA Box.
- **Status:** The "Registered" indicates the VA Box is registered to the NVR and "Not registered" indicates the VA Box is not registered to the NVR.

VA BOX_Setup

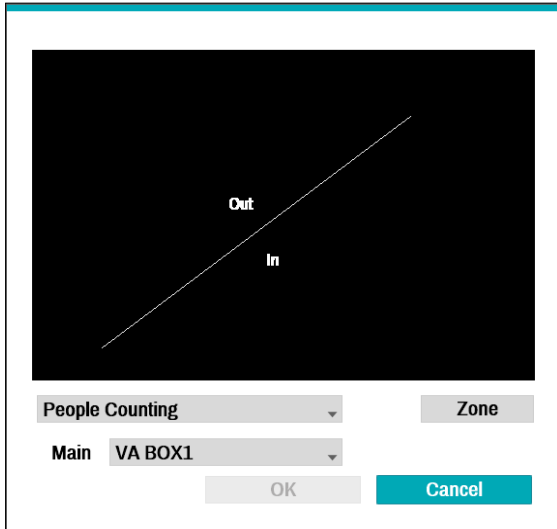
Configure VA Box-related settings.



- **Title:** Displays the name of a VA Box.
- **Camera:** Select the camera to analyze the video. Only one camera can be set for each VA Box channel
- **Set up:** The setting items appear differently depending on the VA Box's type. For the setting items, refer to the setting items of each VA Box's type.
 - The video analytics may not be supported depending on the model.
- **Analytic Type:** Select one among People Counting, Crowd Detection, Social Distancing Violation and Mask Rule Violation. A single video analysis function is available for each VA Box channel.

People Counting

Count the number of people passing through the line on the live screen.



Right-click on the zone setup screen to bring up the People Counting Menu.

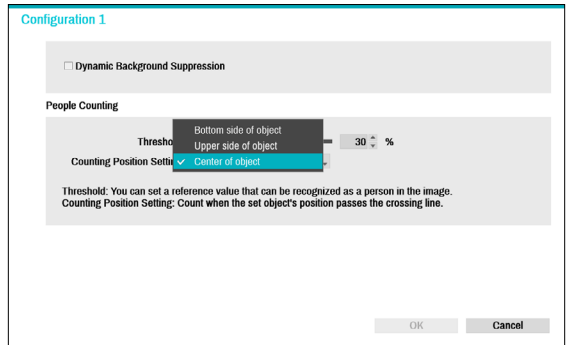
- **Main:** Add the total number of people by sending them to the desired channel. The channel designated as the main can use the Exceed Occupancy Limit event.
- **Boundary:** Set a virtual border to count the floating population.



Depending on the location of the boundary, the number of people may be incorrectly calculated.

- **Save:** Save the changes and exit the menu.
- **Cancel:** Exit the setup screen without saving the changes.

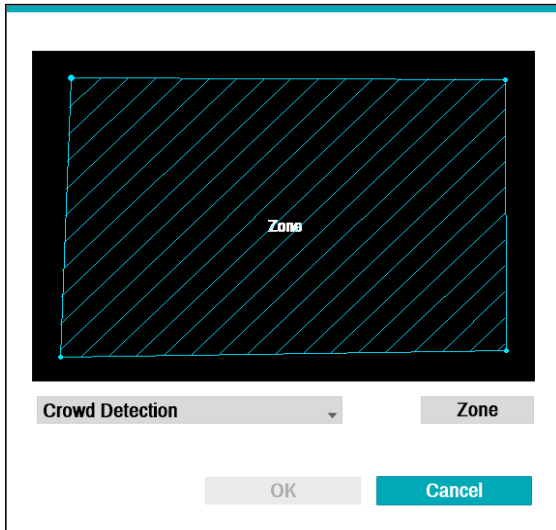
- **Configuration:** Set the environment of people counting. Select People Counting as the video analysis type, and then select Settings. Below is an example of a screen in which the video analysis type is set to people counting.



- **Dynamic Background Suppression:** Recognize the objects (people) even if the background is moving.
- **Threshold:** Set the reference value that can be recognized as a person in the image.
- **Counting position setting:** Set the position of the reference point of a person to count the number of people passing through the boundary.

Crowd Detection

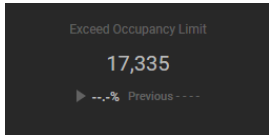

Time Shift of Graph
